

Internet Privacy Policy

1. Introduction

This website with URL address: <http://www.ingronwn-toenail-treatment.com.au> (*Website*) is owned and operated by BFF - Best Feet First Pty Ltd (ABN 28 149 692 848) (*Best Feet*).

Best Feet collects and uses personal information from visitors to the Website, including information or opinions which are capable of identifying visitors, such as the visitor's name, address, contact telephone numbers or email address (*Personal Information*). Best Feet does not wish to collect information about visitors which is *sensitive information* as defined under the *Privacy Act 1988 (Cth)* (*Privacy Act*), being information or opinions about the visitor's health, political affiliations, sexual preferences, religious beliefs, racial or ethnic origin or other such private information.

This Privacy policy is important. It applies to the collection, storage, use and disclosure by Best Feet of your Personal Information. Access to the Website is conditional on your approval of this Privacy policy and you agree that your use of the Website implies your consent to the terms of this Privacy policy. 2. Information collected

Best Feet will collect Personal Information about you through your use of the Website.

Best Feet may collect Personal Information about you from related bodies corporate of Best Feet Partners (see section 4), from our distributors and other service providers and when you request information about our products and services. We will only collect Personal Information that is necessary for one or more of our functions.

3. Storage of personal information

However, in the event of a merger, acquisition or sale of the whole or part of the business of Best Feet, we reserve the right to transfer your Personal Information as part of any such transaction.

The Website may contain direct links to other sites operated by Partners or other third parties. You acknowledge that such sites are not operated by Best Feet. Advertisements on the Website and links to or from other sites do not constitute sponsorship, approval, endorsement of the content, policies, practices or services offered on those advertisements or sites.

6. Access to information collected by Best Feet

Best Feet will use its reasonable endeavours to keep your Personal Information accurate. You may obtain access to the Personal Information which Best Feet has collected about you via its Website by contacting Best Feet. Best Feet will use its reasonable endeavours to provide a complete list of your Personal Information within 14 days of receipt of your enquiry.
